## ART. 1 INTRODUCTION

The "*Francesco Cardaropoli*" **International Music Competition** is aimed at young people musicians of both genders pursuant to laws 903/77 and 125/91 and to people of all ages and all nationalities, pursuant to the Decrees Legislative 215/03 and 216/03.

The competition will take place in the city of Bracigliano (SA) at the **Palazzo De Simone** located in via Vittorio Emanuele and it will take place on the dates **from the 5th to the 7th of April 2024**.

## ART. 2 SECTIONS AND CATEGORIES

**SECTION I. JUNIORS** (All the instruments): FREE CHOICE PROGRAM

## ART. 5 EVALUATION

The evaluation of the competitors is expressed in cents.

FIRST ABSOLUTE PRIZE 100/100 score

FIRST PRIZE score from 95 to 99 points

SECOND PRIZE score from 90 to 94 points score

THIRD PRIZE score from 85 to 89 points

DIPLOMA OF MERIT score below 85 points

For those who have reported an evaluation, unanimously attributed by the jury, of **100/100 absolute first prize** will compete in the final evening, on the 7th April 2024, for the assignment of the Special Prizes.

Furthermore, all the absolute first prizes will win a ceramic trophy; for the groups, each participant will win a medal.

**IMPORTANT:** failure to participate in the final evening will result as loss of the award and of any scholarships.

The Jury reserves the right not to assign the cash prizes.

### **ART. 7 RULES**

- 1 All competitors, at their arrival in the location of the Competition, they will have to go to the SECRETARY for the registration and they will have to show up at least 50 minutes before the start of each Section / Category, as indicated in the calendar that will be promptly communicated in accordance with the art. 4.
- 2 Competitors must present:
  - An identification document
  - Two copies of the pieces to be performed for the Jury
- 3 Competitors will be able to choose whether to present a solo piece or an accompanied one with the piano.
- 4 Upon request and for a separate fee, piano accompaniment can be provided for the participants by the Organisation. The pianist needs to be contacted at this address: **pianistaconcorso@gmail.com**, before the 20th March 2024.

- 5 The signing of the application form entails unconditional acceptance of the regulation.
- 6 The registration fee includes the VAT. The registration fees are not refundable except for causes and / or responsibilities due to the Organisation.
- 7 Each competitor can enrol in more Sections and in categories higher than his/her age, but cannot participate in a lower category.
- 8 The Jury will be made up of Professors, Orchestra Professors and Musicians of clear reputation who will not have the right to vote if they have relationships of any kind with the competitors.
- 9 The Jury's judgment is unquestionable and final. They are given the right to stop performances at any

time.

- 10 Pursuant to art. 10 of Law no. 675/96 on "Data protection personal, "the" Libera-Mente "Association informs that the data provided upon registration will be stored and used by the same in order to send communications relating to the competition and that, pursuant to of art. 129 of the aforementioned law, the data owner can oppose their use.
- 11 Performances will be open to public. In case of registration and / or radio, television or Internet broadcasting of evidence of the Competition, candidates will have no right to request compensation to the organization of the Competition. The photographic, video and audio material may be used for information purposes (Legislative Decree 196/2003). For any possible controversy will be the competent court of Nocera Inferiore.
